

# Copyright Compliance

A very quick guide to copyright do's & don'ts

## Safeguarding you and your organization

The document you purchased is copyrighted material that may not be reproduced without license. Items purchased in electronic (PDF) format are licensed for single-user access only and may not be shared or resold. The following is a high level common sense approach providing guidance to help you understand the commitment.

### What you can do as an authorized user

- Retain and view the document(s) purchased indefinitely.
- Download and view an electronic document on your computer indefinitely.
- Print a single copy of an electronic document for your personal use.
- Documents purchased in hardcopy format may be shared with or sold to another individual provided the document is not reproduced in any manner.
- Use a de minimis and insubstantial amount of content from a document in a document you create for internal use. Best practice is to reference the standards development organization (e.g., ASTM), document number, revision status, publication date, and paragraph number.

### What You Cannot Do As An Authorized User

- Further reproduce or photocopy a document you purchased or printed from an electronic copy.
- Scan or electronically reproduce any hardcopy document.
- Share access to an electronic document you download or printed with any other individual without purchasing a multi-user license.
- Save an electronic document to a corporate network that is accessible to other individuals without purchasing a network license.

- Post an electronic document or any part thereof to a public network or website.
- Develop a derivative work from the document.
- Remove, obscure or modify the content or any other markings on a document you purchase, download or print.

If you are unsure if the way in which you want to use a standards organization's content is permitted, please ask either your legal counsel or the Standards Developing Organization in question.
